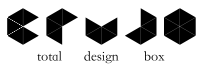

ART. 3 TERMS AND PAYMENT CONDITIONS

Any company declaring its intention to participate in the event as exhibitor by signing the appropriate participation form will receive a corresponding order confirmation and regular invoice for 100 % of the total amount and in any case before the beginning of the event.

ART. 4 CANCELLATION

If the applicant will not send cancellation as described above or indeed participate in the exhibition, they will be obliged to pay the entire amount stipulated, subject to the Organizer’s right to request further compensation for any additional damages.

In the event that exhibition spaces have been made available to the applicant, the organizer may re-allocate these. If the area is let to another exhibitor, the penalty will be reimbursed, after the event, in proportion to the sum received for the resale.

ART.5 USE OF THE LOGO

Publishers must insert the Fruit exhibition logo on all promotional material concerning “Fruit Exhibition”.

ART. 6 COPYRIGHT – PERSONAL IMAGES

6.1 The intellectual propriety of every editorial items entered in the exhibition belongs to the original owners.

The participants give the permission to CRUDO to publish on-line materials which are part of the application (or part of such materials), to publish pictures of materials exposed and participants just to promote Fruit Event, any money which comes from



that activities will be returned to the participants by CRUDO.

6.2 The participants give permission to CRUDO to reproduce pictures of their own faces (including parts) in order to promote the Fruit event.

ART.7 LIABILITY FOR THEFT AND DAMAGE

CRUDO will provide dedicated staff in order to sell and supervise books.

Participants exonerate the Organizer from any responsibility relating to theft or damage which may occur to the participant's detriment.

Participants shall not hold the organizers responsible in any way whatsoever for any damages which may be caused by the Participant him or herself or by his or her personnel.

ART.8 POSTPONEMENT, REDUCTION AND SUSPENSION OF THE FESTIVAL
